# JUNIOR RODEO

## Monday, July 31<sup>st</sup> 2017

1. Open to Uinta and Rich County Residents only
2. Uinta County Fair Jr. Rodeo is open to any youth, ages 8-18 years of age, unmarried, residing in Uinta County, Wyoming or Rich County, Utah.
3. Age as of January 1, 2017.
4. The entry fee of \$15 per event, per person must accompany the entry form. The entry forms are due by July 21, 2017 or postmarked no later than July 18, 2017...NO EXCEPTIONS.
5. Complete address and parent or guardian signature is required for the entry to be accepted.
6. There will be NO REFUNDS of entry fees.
7. The All-around cowgirl and cowboy awards will be figured by a point system to include all events. ie, 1<sup>st</sup> -5 points, 2<sup>nd</sup> - 4 points, 3<sup>rd</sup> - 3 point, 4<sup>th</sup> - 2 points and 5<sup>th</sup> - 1 point. All timed events have a sixty second time limit.
8. Mail or bring entry forms to the Uinta County Fair Office (P.O. Box 636 or 122 Bear River Drive Evanston, WY 82931)
9. Participants in team roping can enter two times and must switch ends, and/or enter one time with a girl. Participants in ribbon roping can enter two times if positions are switched.
10. You may enter either calf roping or goat tying but not both.
11. Participants in individual events can only enter one time. If you move up an age group- it will not count towards your all around points. Ribbon roper's may have a dally or they may tie off. Entrants must choose a neck rope or dally. If they don't dally they can mug.  
12-14 can rebuild and 15-18 can carry two loops.
12. Breakaway Roper 8-14 can rebuild, girls 15-18 can carry two loops.
13. Calf Roper's must have a neck rope and can carry two loops (15-18).
14. Any disruption in starting of the cattle will result in disqualification. (Holding tails, horns, etc)
15. Horse must be in back of the box before calling for cattle.
